#### PERMIT TO USE AN EXISTING WELL

# ISSUANCE OF THIS PERMIT DOES NOT CONFER A WATER RIGHT CONDITIONS OF APPROVAL

- 1) This well shall be used in such a way as to cause no material injury to existing water rights. The issuance of this permit does not ensure that no injury will occur to another vested water right or preclude another owner of a vested water right from seeking relief in a civil court action.
- 2) The construction of this well shall be in compliance with the Water Well Construction Rules 2 CCR 402-2, unless approval of a variance has been granted by the State Board of Examiners of Water Well Construction and Pump Installation Contractors in accordance with Rule 18.
- 3) Approved pursuant to CRS 37-90-107(7) and the Findings and Order of the Colorado Ground Water Commission dated June 27, 2023, for Determination of Water Right No. 4535-BD, for a change of use of an existing well, constructed under permit no. 329008.
- 4) Issuance of this permit cancels permit no. 329008.
- 5) The use of groundwater from this well is limited to domestic use inside 1 single-family dwelling, including the watering of domestic animals and livestock and the irrigation of 1 acre of lawns and gardens. The place of use shall be limited to the 41.18 acre land area claimed in the above described Order of the Commission.
- 6) The pumping rate of this well shall not exceed 15 GPM.
- 7) The allowed average annual amount of groundwater that may be withdrawn by this well under this permit may not exceed 1 acre-foot, subject to the conditions of Determination of Water Right no. 4535-BD including but not limited to the allowed maximum annual amount of withdrawal.
- 8) The total amount of groundwater that may be withdrawn from the Aquifer by all wells operating under this plan may not exceed an annual volume of 10.18 acre-feet, subject to the conditions of Determination of Water Right No. 4535-BD.
- 9) Production from this well is restricted to the Arapahoe aquifer.
- 10) A totalizing flow meter or Commission approved measuring device must be installed on this well and maintained in good working order. Permanent records of all diversions must be maintained by the well owner (collected at least annually) and submitted to the North Kiowa-Bijou Ground Water Management District and the Ground Water Commission upon request.
- 11) The owner shall mark the well in a conspicuous location with the well permit number and name of aquifer as appropriate, and shall take necessary means and precautions to preserve these markings.
- 12) This well shall be located within 200 feet of the location specified on this permit.
- 13) At least four percent (4%) of the amount of water withdrawn annually must be returned to the uppermost aquifer in the vicinity of the well.

NOTE: This well is withdrawing water from a non-renewable aquifer. While the withdrawals from this aquifer are administered based on a 100 year aquifer life, water level declines may prevent this well from diverting the permitted amounts for that 100 years.
